

TRAVIS COUNTY VIP Information:

Our Requirements:

The Travis County VIP is held on the 1st, 3rd, & 4th Wednesday of each month.*

There is no pre-registration - Travis County VIP is not available for online pre-registration at this time.

Attendance is first come first served (on rare occasion there may be limited seating if there is high attendance).

Arrive by 5:30 - 5:45, to be in line when registration sign-in begins at 6:00. Attendees form a line in the courtyard outside the building entrance. Come dressed in respectful attire, cell phones turned off, no texting allowed. Inappropriate conduct will result in ejection and no completion. Stow bags and personal items under seat. Once you register, you cannot leave the building or be excused from the room. After the doors close there is no admittance. The program begins at 7:00 P.M. and ends at 8:30P.M.

Bring a valid ID - photo ID such as a drivers' license (Probation ID, Social Security card or Birth Certificate can substitute).

The cost is \$25.00 - bring a money order made to MADD.

(Parents accompanying their underage child are no charge)

Keep your receipt - it is the certificate proof of your attendance for the court and/or probation requirement (make a copy or take a picture of it for your records)
